7. Change of clause 19 (F).
8. Change of Clause 22

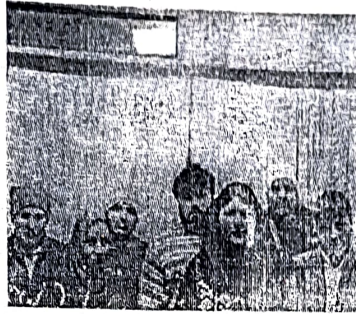
